

1. (W5:1) The <b>prefixes</b> <i>dis-</i> , <i>de-</i> , <i>mis-</i> , <i>over-</i> , and <i>re-</i> create verbs when added to root words.				2. (W5:1. Sp 6:11) The <b>suffixes</b> <i>ate</i> , <i>ize</i> (or <i>ise</i> ), and <i>ify</i> can form verbs from some nouns or adjectives. There may be a slight change of spelling to the root word or the final letter might be dropped.

16-17. (W5:16) When two or more singular nouns or pronouns are connect by 'and', use a plural verb. If connected by 'or', use the singular verb.

18-19. (W5:18) Verbs in the <b>perfect</b> form show an action completed in the past at an unspecified time. They use 'have' (present perfect), 'had' (past perfect), 'will have' (future perfect) before a past participle of the verb. Simple past has a specific time.							
The bird ( <b>flew</b> / <i>flown</i> ) away in the winter.				The bird had ( <i>flew</i> / <b>flown</b> ) away.			
20-21. (W5:19) <b>Expanded noun phrases</b> add information (adjectives) to nouns (either before or after the noun). They can be an efficient way to make writing more interesting and create imagery. Words that add nothing new or are synonymous are repetitive and redundant.							
She began to (start to) write on the blank, (empty) sheet of paper.							
22. (W5:20) <b>Modal verbs</b> indicate likelihood ( <i>must</i> ), ability ( <i>can</i> ), permission ( <i>may</i> ) or obligation. They include the verbs <i>can</i> , <i>could</i> , <i>may</i> , <i>might</i> , <i>should</i> , <i>shall</i> , <i>would</i> , <i>will</i> , <i>must</i> (and their negative forms). They go before other verbs.							
For our holiday, we ( <i>would</i> / <b>may</b> / <i>can</i> ) be going to France.							
23. (W5:21) A <b>relative clause</b> adds more information about the noun in the main clause. They normally come after the noun and start with the words <i>who</i> , <i>which</i> , <i>where</i> , <i>when</i> , <i>whose</i> or <i>that</i> . They start and end with a comma. They turn simple sentences into complex sentences.							
If you want, <b>when I've finished on it</b> , you can have a turn on my computer.							
24. (W5:22) A main function of the <b>comma</b> is to avoid ambiguity (confusion) in sentences. They can help make the meaning clear.							
Every time we eat, my gran makes us sit at the table.							
25. (W5:23) <b>Parenthesis</b> is a word or phrase inserted into a sentence to give extra information, explanation, clarification or afterthought. <b>Brackets</b> enclose it to show that it is separate from the rest of the sentence. Commas or dashes can also be used to show parenthesis.
